If you are planning to check-out very early, you can request a "Breakfast-to-go" package.

Please, let us know in advance or while checking in.

Payment: by cash or card - at the reception desk (We accept most types of credit cards.) (Virtual Card reservations or non-refundable booking are pre-paid on the day of your arrival.)

Pre-authorization of transaction for the first night to confirm that your card is valid is a standard procedure. As soon as the card proves to be valid, the pre-authorization will be cancelled on the very same day. The whole amount will be paid at the receptionist's desk on the day of your arrival, either by cash or your credit card.

(Breakfast, VAT and local tax included.)
(Every room is equipped with its own bathroom with shower.)

Our hotel does not have an elevator/lift and it does not have an Air-Conditioning system. In the summer our hotel is fully booked on a daily basis, therefore we ask you to inform us of your physical dispositions in advance, so we can adjust the accommodation to suit your needs as much as possible.

The hotel is non-smoking, except for the terrace which is always available for use. Smoking inside the hotel will result in a high fee for the guest. Smoking out of the window is still considered as smoking inside the hotel and will result in the fee previously mentioned.

SINCE 1ST OF OCTOBER 2018 IT IS NOT ALLOWED TO DRIVE THROUGH THE HISTORICAL CENTRE OF THE TOWN WHERE OUR HOTEL IS LOCATED, SINCE THE CENTRE IS DESIGNATED AS PEDESTRIAN ZONE. PLEASE, PAY ATTENTION TO THIS MESSAGE! WE TAKE NO RESPONSIBILITY FOR OUR GUEST BREAKING THE LAW AND BEING FINED!

Historical town centre is a dedicated **pedestrian zone**. Motorized vehicle access is restricted to special cases subject to Municipal Authoritity permit with a time limitation.

**Without permition** can enter the town centre only emergency cars, disabled persons and Ambulance vehicles.

**Persons with proof of accommodation** at an accommodation facility within the pedestrian zone:

• Entry is restricted to a time slot between **3 pm and 10.30 am** with a one-time valid permit to enter the pedestrian zone

- Permit price: 100 CZK per max. 24 hours; Permits are issued by the Český Krumlov Municipal Police. Accommodation facility operators can buy one-time entry permits in advance for their guests.
- Outside of the permitted time slots, it is necessary to use a <u>taxi service</u> for transport of persons or bags to and from the pedestrian zone

The permit authorizes its holder to enter the pedestrian zone to transport persons and bags to and from the accommodation facility only. It is not a permit to park the vehicle within the pedestrian zone.
